2.  *Scheduled 2024:* NFPA 1971, NFPA 1975, NFPA 1981, and NFPA 1982 will become **NFPA 1970**, Standard on Protective Ensembles for Structural and Proximity Firefighting, Work Apparel and Open-Circuit Self-Contained Breathing Apparatus (SCBA) for Emergency Services, and Personal Alert Safety Systems (PASS).
3.  *Scheduled 2025:* NFPA 1021 and NFPA 1041 will become **NFPA 1020**, Standard for Fire Officer and Emergency Services Instructor Professional Qualifications.
4.  *Scheduled 2025:* NFPA 1581, NFPA 1582, NFPA 1583, and NFPA 1584 will become **NFPA 1580**, Standard for Emergency Responder Occupational Health and Wellness.
5.  *Scheduled 2025:* NFPA 1951, NFPA 1977, and NFPA 1999 will become **NFPA 1950**, Standard on Protective Clothing, Ensembles, and Equipment for Technical Rescue

7.  *Scheduled 2026*: NFPA 1984 and NFPA 1989 will become **NFPA 1985**, Standard on Breathing Air Quality for Emergency Services Respiratory Protection and Respirators for Wildland Firefighting and Wildland Urban Interface Operations.
8.  *Scheduled 2026*: NFPA 1402, NFPA 1403, NFPA 1404, NFPA 1407, NFPA 1408, NFPA 1410, and NFPA 1451 will become **NFPA 1400**, Standard on Fire Service Training.
9.  *Scheduled 2026*: NFPA 1201, NFPA 1710, NFPA 1720, and NFPA 1730 will become **NFPA 1750**, Standard for the Organization and Deployment of Fire Suppression Operations, Emergency Medical Operations, and Providing Fire and Emergency Services to the Public.

\*NOTE: Separate from the above, on 1/10/24 consolidated standard **NFPA 1550 Standard for Emergency Responder Health and Safety**, incorporated NFPA 1500, NFPA 1521, and NFPA 1561.
