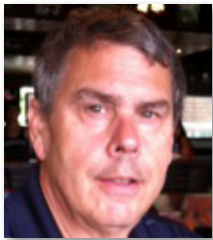


**Gregg Speed** - Safety Director, Hancock Lumber

**Engaged & Empowered: Everybody Leads!**

**Do your employees reflect and experience the goals of your Safety Mission Statement? Gregg will share Hancock Lumber's 5 year journey that began as a quest to become a "Best Place to Work", and through that process revolutionized their safety culture. Some key change items: Letting go of "Top Down" management styles and replacing with employee driven thoughts, ideas and dreams using third-party surveys; Asking the right questions, listening through focus groups and then implementing change. Hancock Lumber Co. currently operates all three of its Eastern White Pine Sawmills and one Retail Lumber Yard in the SHARP Program.. Auditorium**

Gregg Speed is the Safety Director at Hancock Lumber Company, based in Casco, Maine. For 21 years Gregg has been responsible for all aspects of workplace safety and health. Before Hancock Lumber, Gregg was a classroom science teacher, football/basketball coach, and a NATA certified athletic trainer. Teaching, coaching, and sports medicine has served him well, to encourage and support the 490 Hancock Lumber employees. Gregg has presented as a speaker on a variety of safety topics at the state, regional and national Lumber Dealer Associations. Hancock Lumber has hosted the OSHA Training Institutes Logging/Sawmill Program several times and will once again in August 2018 at their Casco Mill.

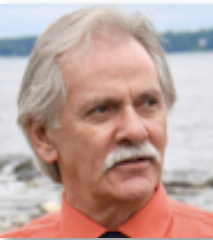


**Mark Heffron** - Technical Support Specialist, OSHA

**Fall Protection & Prevention Requirements**

**In 2016, OSHA passed a final rule expanding the scope of the existing walking and working surface standard for general industry and adding a general industry fall protection component. The new rule requires employers to identify fall hazards in their workplace, and establish plans and procedures to ensure that slip and fall hazards on floors are guarded. This program covers the various fall protection systems for different types of walking-working surfaces. 11th Floor Marriott**

Mark has served as an EH&S safety professional in construction, general industry, transportation and environmental industries since 1979 and presently is Sr. Safety and Health Specialist & Emergency Management Coordinator OSHA Region 1 Boston Office. In both enforcement and technical support throughout New England area, he serves as the Region 1 Subject Matter Expert in fall protection. He is a presenter of Safety and Health subject matters at Professional Development and Safety Symposiums, and serves as the primary liaison to federal, state & local, government agencies.



**Steven Gauthier** - CMFS - OTI Instructor

**Basic Introduction to Machine Guarding**

**2017—injuries are down from 2,448 in 2016. Point-of-operation hazards account for most violations. Machine guarding is meant to protect workers from point-of-operation hazards and dangers caused by ingoing nip points, rotating parts, flying chips and sparks. The main focus of this session is to familiarize the participant with knowledge and skill in proper machine safeguarding techniques, and to highlight the benefits of guarding various types of machinery. Stephen Gauthier has almost 40 years of experience as a machinist and leader in EH&S programs in the manufacturing sector, VPPPA, and agencies impacting safety and health in the workplace. He is currently an OTI Education Center Region 1 instructor for OSHA Machine Guarding courses, Safety and Health Management, Incident Investigation, and key OSHA learning objectives in General Industry. Author of published articles on Green Chemistry and Metalworking Fluids, Steve remains a critical voice for workers, active in the Toxic Use Reduction (TURA) program having served 10 years as member of the TURA Advisory Committee.



**Alden Davis** - Principal, MyValueTree

**Learning Situational Awareness**

**OSHA Case Studies: Beryllium**

**Diving - Rm 165-169**

**Cathy will discuss an interesting OSHA inspection, in which workers sampled were found to be exposed to Beryllium in excess of four times the OSHA PEL, while performing machining operations. Cathy will cover the effects of beryllium exposure on the human body.**

Prior to joining OSHA, Catherine worked in private industry for 12 years with positions in industrial hygiene, safety, and emergency response. Catherine holds a BA degree in Biology from Concordia College and an M.S. degree in Environmental and Occupational Health and Safety from the City University of New York, Hunter College.

**In December of 2016, an underwater diver, hired to inspect the inside of a massive, multi-story water tank, died in the frigid waters after reporting a problem with his air supply. An intense rescue effort ensued after the victim lost communication with a spotter atop the million-gallon tank. Bill will discuss the accident and the OSHA investigation that followed.**

Bill has been an OSHA Safety and Health Compliance Officer for 8 years. Prior to this, he spent 18 years in marine construction and commercial diving. He is a US Navy veteran, serving 6 years as a boiler technician on board the battleship USS Iowa, and has an Associate Degree from the College of Oceaneering.

**Industrial Hygiene: OSHA Update**

**Amee will discuss what's going on with OSHA in Region 1, including some interesting topics, enforcement strategies and policies. Also covered are recent compliance inspections that have highlighted safety and health concerns for employees in workplaces throughout New England.**

Amee Bhatt is the Assistant Regional Administrator for Enforcement Programs and Technical Support in the Boston Regional Office. She and her team provide technical guidance on safety and health topics, and provide guidance on OSHA standards, policies and procedures. She began her career with OSHA in 2004 as a Compliance Officer in the Braintree, MA Area Office. Ms. Bhatt is a certified industrial hygienist and has a Master of Public Health in Environmental and Occupational Health degree from Emory University, Atlanta, GA..



**Samuel Knight** - 21D Program Manager/Supervisor

**Walking Working Surfaces**

**OSHA issued a final rule on Walking-Working Surfaces and Personal Fall Protection Systems, which became effective on January 17, 2017. This session will cover changes to employer responsibility when it comes to training employees, trainer qualifications, inspection, and use of fall protection.**

Maine Dept. of Labor/Bureau of Labor Standards (1991 to 2018) Samuel Knight has been dealing with safety since 1985 as a Union representative at the power plant at Pineland Center, where he worked as a Power Engineer. He has an Associate Degree in Power Engineering and 2<sup>ND</sup> class Engineers license. In 1988 Sam completed an Associate Degree in Safety and Health from Central Maine Community College. Sam went to work for the Maine Dept. of Labor in 1991 as a Safety Engineer, 1996 to 2006 MDOL Safety Enforcement Officer, 2006 to 2014 Occupational Health Specialist, and in 2014 Sam became the Program Manager/Supervisor of the 21D grant (OSHA) and the Mine Safety and Health (MSHA) programs in the State of Maine.



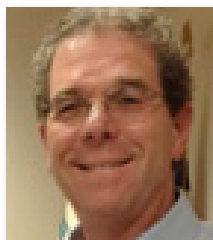
**Dr. Jack Dennerlein** - professor, Northeastern University

**Health Safety & Culture**

**This talk examines ways to reduce injuries and accidents by improving safety culture and climate through changes in organizational policies, programs, and practices. Rather than focusing on unsafe acts performed by lower-level employees, who do not have the capability of changing the values of an organization, create a culture that generates safety.**

**Rm 163C**

Dr. Dennerlein is an engineer whose research in public health takes a systems approach to understand and prevent work-related injuries and thus improve worker health and well-being. He holds degrees from the State University of New York at Buffalo, the Massachusetts Institute of Technology, and the University of California, Berkeley. In addition to his work at Northeastern, he is also a Professor of Ergonomic and Safety at the Harvard T.H. Chan School of Public Health.



**Michael Ziskin** - Principal, Field Safety Corporation

**PPE: Myths & Misconceptions**

**Myths and misconceptions regarding personal protection will be explored on a variety of topics, such as "Having personal protection means I am safe", "All forms of gloves are the same", "All respirators are created equal", "Cleaning, inspecting and replacing personal protection is not that important", "Reaction time vs. donning time", "OSHA compliance with Personal Protection and human factors".**

Michael has been wearing PPE for over thirty years while climbing smoke stacks, working in chemical, steel, manufacturing and power industries, and cleaning up toxic dumpsites and hazmat response. He has also conducted research and testing on the performance of PPE for NFPA and ASTM, as well as for PPE manufacturers since 1986, and published numerous papers and authored chapters of textbooks. He serves on committees of national organizations (AIHA, NFPA and ASTM) involved with developing standards and guidelines on PPE. Michael is also a lead instructor for the OSHA Training Institute Education Center Region 1 and adjunct faculty Keene State College. He holds certifications in Hazard Control Management and Hazardous Materials Management, Business Continuity, and Electric, Gas, Power Generation and Civil Safety.



**Jim Mulligan** - OSHA Assistant Area Director, Braintree MA

**Steve Falter** - Safety and Health Compliance Officer- Concord NH

**OSHA Case Studies: Crane Tent - Rm 165-169**

Two linemen were killed when a 40 ton crane tipped over while work was being performed on overhead powerlines. John will discuss the accident, the OSHA investigation that followed, and the mistakes made and violations uncovered as a result of this tragic event.

Jim Mulligan is an 18 year OSHA employee and is currently the Area Director in Braintree, Massachusetts. Throughout his OSHA career, he has worked in a variety of positions in the Boston Regional Office and the Braintree Area Office. Mr. Mulligan is a Boston College graduate and is a Massachusetts licensed master and journeyman plumber. Prior to working for OSHA, Mr. Mulligan worked in high rise steel and concrete construction for 13 years.

During a circus show at the Lancaster NH fairgrounds in 2015, high winds from a microburst collapsed the big top circus tent, injuring over 2 dozen and killing 2 patrons. Steve will discuss the timeline of the events preceding the incident, the multi-agency incident response, and the concurrent OSHA inspection conducted with the NH Fire Marshal and NH State Police.

Steve started his career with OSHA in 2007 as a Construction Safety Compliance Officer with Boston Area South Office. He currently works in the Concord Area Office, specializes in process safety management, and has conducted numerous significant OSHA inspections, and is part of the Region 1 wind tower team. Prior to joining OSHA, he was a Safety Manager for a General Contractor in Newton MA. Steve is a graduate of Keene State College with a B.S. in Occupational Safety.



**Heather White**

**Suicide in the Workplace**

After nearly losing her life to post-partum depression and suicide, Heather White began to learn more about mental health and suicide prevention efforts. She is currently the Area Director for the American Foundation for Suicide Prevention in Western Massachusetts and Vermont, an ASIST trained suicide intervention caregiver, and a Talk Saves Lives and safeTALK Suicide Prevention trainer. **Rm 168C**

AFSP creates a culture that's smart about mental health through education and community programs, develops suicide prevention through research and advocacy, and provides support for those affected by suicide. Degree in Government from Western New England University and earned his Master's Degree in Business Administration from Elms College, where he currently serves on their MBA Advisory Council. He started his career with Hampden County Sheriff's Dept. in 1993 as a Correctional Officer. In 2016, he was elected to be the 16th Sheriff of Hampden County.

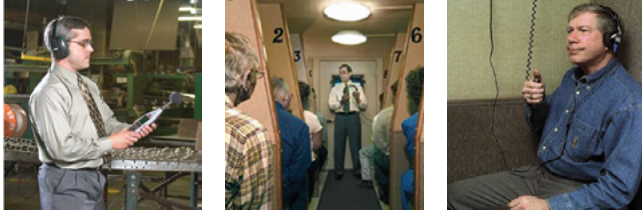
