

Goal: Help employers identify and control workplace hazards to prevent work-related injuries, illnesses and fatalities

#### Benefits:

- Opportunity to work with experienced safety and health professionals
- No penalties are assessed
- Confidential
- Separate from enforcement



### On-Site Consultation Visits by Industry Sector




